The study examines the Russian conception of property with reference to the country's legal culture, tracing the continuity of Russian legal thinking from the Tsarist empire to the current era and considering how this thinking has impacted the modern legal rules on property law. The volume was published in February 2019 by the Mohr Siebeck Publishing House.
